1. Approval of the Minutes of the February 13, 2007 meeting.

2. Request authorization to schedule a Public Hearing on March 29, 2007 at 2:00 p.m. to consider the proposed Caritas St. Elizabeth's Medical Center Institutional Master Plan.

3. Request authorization to schedule a Public Hearing on March 29, 2007 at 2:15 p.m. to consider the proposed Smart Growth Overlay District Zoning Articles. **APPROVED**

4. Request authorization to amend the September 30, 2004 vote regarding the disposition of unbuildable BRA-owned parcels for use as open space in Roxbury for abutters to allow parking use and structures associated with parking and open space.

Request authorization to accept an assignment from the Department of Neighborhood Development of its rights, title and interest in an affordability covenant encumbering 42 Burgess Street and to take related actions that will permit the transfer of \$33,000 to the Department of Neighborhood Development for use in the creation of an affordable unit of housing and will complete the site preparation for the Salvation Army of Massachusetts Inc.'s Kroc Center Project.

14. Request authorization to enter into an amendment to the Ground Lease for Building 38 in the former Charlestown Navy Yard with Building 38 Ventures Limited Partnership to permit Building 38 to be converted into an office condominium. **APPROVED**

15. Request authorization for a 180 day tentative designation extension of Roslindale Field Development Corporation as redeveloper of Parcel SWC-1 for the construction of twenty-two residential units, of which eleven will be affordable. **APPROVED**
16. Request authorization to award a grant to Roslindale Village Main Street, Inc. to engage in a strategic organizational planning process for \$15,000, funding to be provided by the Boston Redevelopment Authority. **APPROVED**
